

# APPLICATION TO ESTABLISH A SCHOLARSHIP FUND

#### The Elk Grove Regional Scholarship Foundation administers two types of scholarships:

#### **Endowment Scholarship**

An "endowment" scholarship is one that achieves the goal of at least \$20,000 invested within a six (6) year period or less. When fully funded at the \$20,000 endowment level, the endowment will be allocated four (4) scholarship units. Expanded levels are in \$5,000 increments (above the initial \$20,000) and will increase the scholarship by one unit each. *As of November 2007, each unit represents \$250 in scholarship dollars awarded; however, unit values are adjusted according to prior year's earnings, subject to Board approval.* The full endowment contribution must be received by the Foundation by March 30 a full year prior to the scholarship being awarded.

#### **Pass Through Scholarship**

This is a one-time scholarship funded no later than September 30 of the year prior to the May *Spotlight on Scholarships* Award Night (a minimum of \$1,000 is required with a \$25 annual processing fee).

• You may select and create the criteria for the scholarship you are establishing within IRS guidelines. These may include such things as grade point average and college major.

## What are the Steps to Establish a Scholarship with the Elk Grove Regional Scholarship Foundation?

- Complete the included *Application to Establish a Scholarship* and return it to the Foundation.
- Include initial contribution and \$25 processing fee made payable to Elk Grove Regional Scholarship Foundation with the scholarship name on the memo line of the check.
- Your application will be reviewed by the Scholarship Committee. This committee may contact you for clarification or further information. An e-mail address is necessary.
- The Scholarship Committee will recommend acceptance or rejection of the scholarship. (Your application will not be forwarded to the Board until it is complete.)
- The Elk Grove Regional Scholarship Foundation Board will accept or reject your scholarship.
- You will be notified of the Foundation's decision.

#### Application deadline is September 30 of the year prior to the May Spotlight on Scholarships event.

Note: Please be advised that this application is subject to the Scholarship Policy in effect as of the date hereof and that the policies, terms, and conditions set forth in the Scholarship Policy shall control any contribution by you in establishing a scholarship fund. Once the scholarship has been approved and established, it will be subject to any amendments and changes subsequently made to the Scholarship Policy by the Board of Directors. Please consult with your tax advisor regarding tax deductibility of any donation to the Elk Grove Regional Scholarship Foundation.

#### **Disclosure Statements**

The following are provided as a general overview of the Elk Grove Regional Scholarship Foundation's policies. A detailed outline of the policies will be given upon request.

## Investments

The Elk Grove Regional Scholarship Foundation is a 501(c)(3) tax-exempt organization whose mission is to facilitate the development of educational opportunities through scholarships and grants, and to coordinate contributions and programs to meet community needs. Many of the scholarships are endowments or are trying to grow to endowment level, so that they can provide scholarships through the earnings of the endowment.

The Portfolio is intended to be structured to provide a reasonable return on invested assets with an emphasis on conservation of principal. To accomplish, the Foundation has a portfolio comprised of mutual funds, fixed income, and cash equivalent securities.

## **Scholarship Policy**

An **ENDOWMENT SCHOLARSHIP** is established when contributions totaling at least \$20,000 are on deposit with the Foundation. No Endowment Scholarship Units will be awarded unless the Endowment Scholarship becomes a mature Endowment within six (6) years of the establishment of the Endowment Scholarship. At that time, four (4) Endowment Scholarship Units will be awarded. Each Endowment Scholarship Unit will entitle the Mature Endowment an award of \$250 Annual Scholarship money with the minimum of any one Annual Scholarship being not less than \$1,000 per year. Thus, a Mature Endowment will be represented by on annual \$1,000 Scholarship. The Board reserves the right to adjust annually the amount of Annual Scholarship to be awarded per Scholarship unit To attain the Expanded level accumulated contributions totaling \$5,000 above the Endowment Level must be received. Each Expanded level will be allocated an additional Scholarship Unit.

**PASS-THROUGH FUND**: The Pass-Through Fund accounts for all specific receipts for scholarships that are designated to be disbursed on an annual basis. The minimum amount for a Pass-Through Fund is \$1,000 plus a yearly processing fee of \$25 per scholarship recipient.

## **Arm's-Length Selection Process**

In order to preserve the integrity of the EGRSF's Internal Revenue Service Code Section 201(c)(3) status, independence is managing and disbursing funds must be strictly maintained. If during the selection process, a donor or immediate family member of a Donor participates in the selection process, that person will be referred to as a "disqualified person" for that Selection Committee. The Selection Committee will then request an independent review of their selection to assure that there has been no breach of independence in their selection process. Any scholarship applicant that is an immediate family member to any person serving on a specific Scholarship Selection Committee will be disqualified for that specific scholarship. Once the EGRSF accepts contributions, those contributions are exclusively under the control and responsibility of the EGRSF.
